**PROCEDURE FOR SELECTION OF THE IMPLEMENTING BODY OF PART OF THE PROGRAM OF INFORMATION AND PROMOTION
OF AGRICULTURAL PRODUCTS ON THE INTERNAL MARKET**

DETERMINATION N° 1 OF THE PRESIDENT OF 23.02.2024

On 23.02.2024 at 17.00 at the headquarters of the Consorzio per la Tutela del Franciacorta, located in ERBUSCO (BS) - 25030 Via G Verdi 53, the President of the Consorzio per la Tutela del Franciacorta – considering that the deadline for the submission of bids for the tender in question expired at 12.00 am on 23.02.2024, by virtue of the Resolution of 12.12.2023 which confers on the President the necessary powersto appoint the Evaluation Commission, proceeds to appoint the Evaluation Commission for the bids received, identifying its members in the persons of:

Pursuant to art. 93 of Legislative Decree 36/2023, with reference to this procedure, the appointment of the RUP (in the person of Gianluca Agati) as appointed commissioner is considered indispensable as the only subject of this Body in possession of the professionalism and all the necessary skills for the correct conduct of the procedure.

The above-mentioned persons have adequate experience in the specific sector to which the subject of the contract pertains, as can be seen from the curricula vitae on file with the Consortium, and do not present any causes of incompatibility or prohibition in relation to the performance of the role of members of the Evaluation Commission, as can be seen from the declarations signed by them (on file with the Consortium).

The commission chose to use English, a language that all commissioners knew, for this procedure. Therefore, the minutes and related documents of this procedure will be in that language.

The President acknowledges that for the above-mentioned functions, the members of the Evaluation Commission will carry out their task free of charge with possible reimbursement of expenses incurred by the commissioner's body of origin.
